

Epclusa[®] (sofosbuvir/velpatasvir) Coadministration with Eslicarbazepine

PK DDI Evaluation

Drug interaction studies have not been conducted between the single-tablet regimen SOF/VEL and eslicarbazepine. Based on the PK profile of each active ingredient within SOF/VEL and eslicarbazepine, a PK interaction would be predicted.^{1,2} Coadministration of these agents is expected to decrease the plasma concentrations of SOF and VEL due to the induction of CYP3A4 by eslicarbazepine, leading to reduced therapeutic effect of SOF/VEL. Coadministration of these agents is not recommended. For more information about eslicarbazepine, please refer to its product labeling.²

Relevant SOF/VEL Label Information¹

There is no information in the SOF/VEL product labeling about the coadministration of SOF/VEL and eslicarbazepine.

Clearance of HCV infection with direct acting antivirals may lead to changes in hepatic function, which may impact safe and effective use of concomitant medications. Frequent monitoring of relevant laboratory parameters (INR or blood glucose) and dose adjustments of certain concomitant medications may be necessary. For more information, please refer to Section 7.3 of the SOF/VEL US Prescribing Information (Established and Potentially Significant Drug Interactions).

Available Data

There are no Gilead studies evaluating the coadministration of SOF/VEL and eslicarbazepine.

Additionally, a literature search was conducted in Ovid MEDLINE and Embase databases for studies published between 1946 and October 27, 2025 using search terms that included Epclusa, velpatasvir, sofosbuvir, eslicarbazepine, and related search terms. No relevant citations were found.
