PK DDI Evaluation

Drug interaction studies have not been conducted between the single-tablet regimen SOF/VEL and testosterone. Based on the PK profile of each active ingredient within SOF/VEL and testosterone, a PK interaction would not be predicted.^{1,2} For more information about testosterone, please refer to its product labeling.²

Relevant SOF/VEL Label Information¹

There is no information in the SOF/VEL product labeling about the coadministration of SOF/VEL and testosterone.

Clearance of HCV infection with direct acting antivirals may lead to changes in hepatic function, which may impact safe and effective use of concomitant medications. Frequent monitoring of relevant laboratory parameters (INR or blood glucose) and dose adjustments of certain concomitant medications may be necessary. Available Data

There are no Gilead studies evaluating the coadministration of SOF/VEL and testosterone. Additionally, a literature search was conducted in Ovid MEDLINE and Embase databases for studies published between 1946 and July 25, 2025 using search terms that included Epclusa, velpatasvir, sofosbuvir, testosterone, and related search terms. No relevant citations were found.
