

# Odefsey® (FTC/RPV/TAF) Crushing or Splitting of Tablets

This document is in response to your request for information regarding Odefsey® (emtricitabine/rilpivirine/tenofovir alafenamide [FTC/RPV/TAF]) and the crushing or splitting of tablets.

# Product Labeling<sup>1</sup>

There is no information in the FTC/RPV/TAF product labeling about the crushing or splitting of FTC/RPV/TAF.

In regard to the individual components of FTC/RPV/TAF, TAF and FTC are each soluble in water (TAF solubility of 4.7 mg/mL in water at 20°C and FTC solubility of approximately 112 mg/mL in water at 25°C); however, RPV hydrochloride is practically insoluble in water over a wide range of pH values.

# Available Data on Crushing or Splitting FTC/RPV/TAF Tablets

#### **Gilead Data**

Crushing FTC/RPV/TAF tablets and adding to a liquid medium has not been studied and is not recommended. TAF is soluble in water; however, it has a bitter and burnt aromatic flavor profile.<sup>2</sup> Currently, there are no studies evaluating the pharmacokinetics (eg, oral bioavailability) of a crushed FTC/RPV/TAF tablet dispersed in a liquid medium (eg, milk, water, or juice) and comparing them with the pharmacokinetics of a whole tablet.

Similarly, splitting FTC/RPV/TAF tablets has not been studied, and it is not recommended. Currently, there are no studies evaluating the pharmacokinetics of a split FTC/RPV/TAF tablet versus a whole tablet.

#### **Non-Gilead Data**

A literature search was conducted in Ovid MEDLINE and Embase databases for studies published up to September 23, 2025, using the search terms Odefsey, emtricitabine, rilpivirine, tenofovir alafenamide, cutting, crushing, splitting tablets, and related search terms. No relevant citations were found.
